

Lean, IFOA, and IPD as Defined by Motivation and Means:

How and Why IPD and Lean Lead to Success Research Report, November 2016

LEAN

The specific tools and processes outlined by LCI and the variations developed by the teams that share the intent and spirit of those tools.

INTEGRATED FORM OF AGREEMENT (IFOA)

A multiparty agreement that includes, at minimum, the owner, design professional, and constructor as signatories to the same construction contract.

INTEGRATED PROJECT DELIVERY (IPD)

The contractual project delivery method used by these project teams that created shared risk/reward structures, fiscal transparency, and release of liability.

How to Take the First Step


- Have Lawyer to Lawyer conversations

- List your project complaints would using a different contract method mitigate that?


